5. Reports:

5.1. Financial Report: Financial Statements from September 2023 and October 2023 were presented – numbers as of October 31, 2023:

5.1.1 PAA Account Current balance - \$26,859.72 Cheques not cleared/funds approved - \$5,628.57 Available funds - \$21,231.15

5.1.2 Casino Current balance - \$10,153.11 Cheques not cleared/funds approved - \$0.00 Available funds - \$10,153.11

5.2. Principal's Report:

- Mr. Pedersen is leaving the school (last day is November 30th); starts new position as Principal at Riverview Middle School in Devon on December 1, 2023.
- 2023/24 School Budget: Total Expenditures \$3,704,355.
- Knowledge Nook Wednesdays and Fridays to help students finish work that they are behind on before the end of the term.
- Term 1 ends December 8^{th} and Term 1 Progress Reports will be released on December 13^{th} .

5.2.1 Engagement Grant:

5.3. Trustee Report:

- Council of School Councils (CoSC) event was held October 25th; focused on improving Parental Engagement. After this event, elections for the CoSC executive were held and all positions were filled. Next meeting for Board Chairs will be on January 17, 2024.
- School tours in October for trustees were in Calmar and some Leduc schools.

- Interviews for the Superintendent position have concluded; announcement to be made shortly.
- October Board meeting was held November 1st.
- New Ohpaho Secondary School opening September 2024, for students in grades 8-12.
- November 8th and 9th Board planning to review the budget and compare it to the projections made in the spring. The Board's Strategic Plan for the coming year was created. The Annual Education Results Report (AERR) was analyzed; trends from the COVID period are beginning to reverse but there is still much work to be done.
- Trustees are currently attending the Alberta School Boards Association (ASBA) annual fall general meeting. Black Gold has prepared a policy regarding expanding the funding model for dual credit programs for high school students.
- New high school in Beaumont will be a joint school with STAR Catholic.
